A-1 Macomb County Animal Shelter

Site: Macomb County Animal Control

The mission of the Animal Control Division is to protect the health and safety of Macomb County residents, and to protect animals and promote their humane treatment. They are also responsible for cruelty investigations, dog licensing, animal bite reports and rescue services.

A-2 Lake House

Site: The Lake House – St. Clair Shores

Learn about Lake House which welcomes and encourages all who are touched by cancer to benefit from their free cancer support groups, one-on-one cancer support consultations and guidance, health and wellness activities, stress management activities, and social events.

A-3 Pediatric MotorWerks

Site: Pediatric MotorWerks – Shelby Twp.

Pediatric MotorWerks is a newly opened outpatient clinic specializing in occupational and physical therapy services from birth through adulthood. Services emphasize an interdisciplinary, hands-on and evidenced based treatment philosophy. This is a family-orientated clinic focused on improving a child's function and participation through movement and play.

B-1 Specialized Children & Family Services

Site: VerKuijen Building

Specialized Children and Family Services is a division within Macomb County Community Mental Health, that provides intensive home and community-based services to children ages 0-21, and their families. Services include Infant Mental Health, Wraparound, Autism Benefit case management, Child Waiver, and several evidence-based practices. Their goal is to keep children out of the hospital or residential facilities, while improving the family system as a whole.

B-2 Baker College Dental Clinic

Site: Baker College – Clinton Twp.

The Center for Dental Hygiene Excellence here in our Clinton Township campus offers low-cost dental hygiene services and X-rays in our state-of-the-art clinic where care is provided by students under the supervision of licensed dentist and hygienists. The center is open to all community members and reduces the financial barriers for individuals to receive routine or more advanced periodontal care.

Creative Empowerment Opportunities specializes in the design and implementation of vocational service options and support systems for individuals with disabilities.

B-4 Macomb County Prosecutor's Office

Site: Prosecuting Attorney's Office

Prosecuting Attorney Eric J. Smith is the chief law enforcement official for Macomb County. He and his staff are responsible for speaking for you if you should fall victim to crime, and fight to protect the safety and security of your homes and families. The office is comprised of attorneys, investigators, victim's advocates, and support staff, working in specialized units, to ensure that justice is done and criminals are held accountable for their actions.

C-2 South Eastern Michigan Indians

Site: SEMII - Centerline

South Eastern Michigan Indians, Inc. is a non-profit 501c3 organization, and the only urban Indian center in Macomb, Oakland and St. Clair counties. They provide services for veterans, seniors, youth, child and family services, employment and education and food pantry services. While some programs are American Indian specific by grant eligibility, other services are provided to others requiring assistance.

C-3 Community First Health Centers

Site: Community First Health Centers – New Haven

Discover the benefits of choosing integrated healthcare through a primary care physician over the on-demand services provided by an urgent care or an emergency room with Community First Health Centers' Medical Director, Dr. Joseph Naughton, DO. Integrated health services include nutrition, dental services, mental health counseling, substance abuse treatment (including an introduction to Vivitrol and its positive influence in addiction recovery).

C-4 Macomb County Jail

Site: Macomb County Jail – Mt. Clemens

The Macomb County Jail currently houses over 1,200 pre-trial detainees and prisoners sentenced to one year or less. The facility is staffed by Corrections Officers, Deputy Sheriffs, Sheriff Command Officers, and a variety of support staff and volunteers. Programs provided include counseling services and teaching of life skills necessary to help reduce recidivism. **Attendees will NOT receive a physical tour of the jail, but will experience a presentation with Sgt. Sue Dumas in the training room. Please enter the jail through the WEST entrance.**

D-1 Macomb County Department of Roads and COMTEC

Site: COMTEC – Mt. Clemens

COMTEC allows communication between departments: Sheriff's Dispatch, Roads Department, IT Data Center and Emergency Management. The state-of-the-art center is open 24/7 and monitors, manages, protects and responds throughout the County.

D-2 PACE

Site: PACE of Southeast Michigan

At PACE, the goal is to provide senior community members with the care, medical treatment and support they need to achieve the highest quality of life – while staying independent as long as possible. PACE elder care experts offer an alternative to nursing home placement that features comprehensive, coordinated care for a senior's medical, social and physical needs.

D-3 Thompson Center

Site: Thompson Center - Warren

Take a tour through the Thompson Center. Discover the wealth of resources offered in this multi-agency building. Agencies include Macomb Community Action, M-CHAP, Macomb County Health Department's Nurse – Family Partnership, WIC and MSU Extension. Learn what each of these agencies does to help out their clients.

D-4 CARE Peer Recovery Coaches

Site: Care of SE MI - Fraser

Learn about substance abuse peer recovery coaches and how they are trained to assist others through the progression of learning to recover from addiction. Find out how your agency can utilize these coaches and resources to build skills that promote the well-being of a person in the process of recovery.

E-1 Macomb County Sheriff's Marine Division

Site: Sheriff's Marine Division – Harrison Twp

The Marine Division patrols Lake St. Clair - the busiest freshwater lake in the nation. The Sheriff's Marine Division is mandated by state and federal legislation to provide a search and recovery team to recover drowning victims from any body of water in Macomb County. They enforce and investigate all violations of marine and criminal state laws that occur on the lake, and also provide a comprehensive boating safety program. **Weather permitting - participants will go out on the boats so dress accordingly. To access the Marine Division, enter through the boat launch access off of South River Road.**

E-2 Sacred Heart Rehabilitation Center

Site: Sacred Heart – Richmond

Sacred Heart provides a full continuum of care services: Detoxification, Adult Residential, Women's Specialty, Outpatient, Medication Assisted Treatment, HIV/AIDS Care, prevention, Peer Recovery Support and Supportive Independent Living.

E-3 Martha T. Berry Medical Care Facility

Site: Martha T. Berry MCF
