



# Behavior Treatment Plans: Policy, Process, Presentation

The course will cover MDHHS behavior treatment plan expectations along with MCCMH policy. The course will also cover basics on writing functional behavior assessments and treatment plans. Restrictive and intrusive techniques will be defined and expectations of case presentation and documentation protocols.

### Course Objectives:

- a. Participants will be able to identify DHHS expectations on behavior treatment plans and any updates to state contractual obligations and current MCCMH policy will be discussed.
- b. Participants will be able to identify the definitions of restrictive and intrusive techniques.
- c. Participants will be able to recall the basics concepts of writing functional behavior assessments and basic concepts of behavior treatment plans.
- d. Participants will be able to identify the documentation needed for presentation to the BTPRC and identify appropriate data collection measures to treat problematic behaviors.

Agnes Ward, PhD, LP, CAADC: Dr. Ward is the current chair of the Macomb County Behavior Treatment Plan Review Committee and has been responsible for policy process and implementation. Dr. Ward is the former chair of Macomb County's Trauma Informed Care committee and was directly involved in planning, development, and implementation of Macomb CMH becoming a trauma informed PIHP. Dr. Ward is a certified Trauma-Focused Cognitive Behavioral Therapist and provided supervision for therapists undergoing the certification process. Dr. Ward also serves as consultant and adviser for agencies seeking to become trauma informed and has advised on process, procedures, as well as physical space/aesthetics. Dr. Ward has presented to clinical professionals, educators, and community groups on the effects of trauma across the lifespan and on implementing a trauma informed system of care. Dr. Ward specializes in the treatment of trauma, post-partum depression, self-injury, and eating disorders. She has extensive experience with severe mental illness and working with patients in the hospital and clinic setting. Dr. Ward is a national trainer for Mental Health First Aid, a course designed to give individuals the tools to assist others who may be developing a mental illness or mental health crisis situation. She completed her doctoral degree at Wayne State University researching personality and risk-taking behaviors in emerging adulthood. Dr. Ward is also a Certified Advanced Alcohol and Drug Counselor.
